Balance will be adjusted accordingly and is final. A 15% drop in attendance will be subject to an increase in fees of \$5pp. A 25% drop will be subject to an increase of \$7pp. FINAL BALANCE IS DUE 3 DAYS PRIOR TO EVENT. Accepted by check, Zelle, bank transfer, or credit card. Credit card payments are subject to a 4% merchant processing fee. A damage authorization form is required for replacement fees of damaged, missing or broken items (i.e. linens, decor, glassware, furniture etc.) and any fees that may arise on the day of the event (i.e. extended event hours, additional liquor, special requests etc.).
